**ALTERNATIVE ARRANGEMENT FOR THE WRITESHOP ON THE
FINALIZATION OF THE DEVELOPED G10 ALTERNATIVE DELIVERY
MODE LEARNING RESOURCES (ADM-LRs)**

To: All Schools Division Superintendents

1. In view of the COVID-19 Stringent Social Distancing Measures along with the guidelines on the Enhanced Community Quarantine, the Writeshop on the Finalization and Printing of Grade 10 ADM LRs to be held at NEAP RO1, San Vicente, City of San Fernando, La Union on March 17-18, 2020 as stipulated in Regional Memorandum No. 168, 2020 shall not be conducted as scheduled but rather adopt an alternative arrangement of implementing.

2. This alternative scheme is a rejoinder to the implementing measures of the department in ensuring the continuity of its delivery of essential services and priority projects like the provision of ADM LRs while observing the stringent social distancing measures.

3. The Regional ADM supervisor shall track the completion and submission of the G10 ADM LRs.

4. The alternative arrangement shall be guided by the following schemes:

4.1. The finalization of the G10 ADM LRs shall be subject to "work at home" or other off-site location as may be strategized by the team.

4.2. The identified team (see attached RM # 169, s. 2020) through the lead and guidance of the EPS In-charge of AP/Filipino/Science/ MAPEH, together with the EPS In-charge of LR & the EPS In-charge of ADM shall collaborate in the completion of the assigned learning area thru telecommunicating arrangements (The composition of the involved team in the finalization may change if necessary)
