2020 SUBMISSION OF CHILD PROTECTION REPORTS

To: All Schools Division Superintendents

1. The Department of Education Regional Office I continue to update its regional data base on Child Protection reports as mandated by DepEd Order No. 40 s. 2012 or the DepEd Child Protection Policy.

2. DepEd Memorandum No. 114 s. 2017 with subject "Reiteration of the Reportorial Obligation of Schools, Schools Division Offices, and Regional Offices pursuant to DepEd Order No.s 40, s. 2012, 55, s. 2013, and 18, s. 2015 including DM No. 59, s. 2015 and 68, s. 2014, mandates the submission of child protection reports. The reports include:

A. Consolidated Report on Incidents of Bullying (SY 2019-2020);

B. Consolidated Report on Incidents of Child Abuse (SY 2019-2020);

C. Consolidated Report on Cases Involving Child-at-Risk and Children in Conflict with the Law in Schools (SY 2019-2020);

D. Consolidated Report on Schools with Localized Child Protection Policy and Anti-Bullying Policy (SY 2019-2020); and

E. Consolidated Report on Schools with Established Child Protection Committee (SY 2019-2020).

3. Submission of reports shall now be made using Google Sheets/Forms platform. In line thereto, all Schools Division Offices are requested to recommend the following: a) focal person/s tasked to upload or input data b) E-mail addresses of the Focal Person/s (DepEd Email only) c) contact number of the focal person/s. Submit the same to lu.region1@deped.gov.ph on or before November 20, 2020.

4. The Regional Legal Unit shall directly coordinate with the division focal person for details and other concerns on the use, access, and management of the google sheets/forms.
