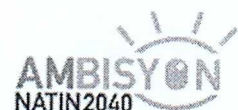

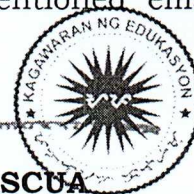
1. Schools that are territorially or geographically located within the city but are under the jurisdiction of the Division Office in the province;
