**CONDUCT OF COMPREHENSIVE SEXUALITY  
EDUCATION (CSE) CONFERENCE**

To: Schools Division Superintendents

1. The Department of Education through the Bureau of Curriculum Development (BCD) in collaboration with United Nations Population Fund (UNFPA) and Center for Health Solutions and Innovations Philippines, Inc. (CHSI), shall conduct a Comprehensive Sexuality Education (CSE) Conference on April 27, 2021 to facilitate the sharing of experiences and updates related to the CSE program implementation.
