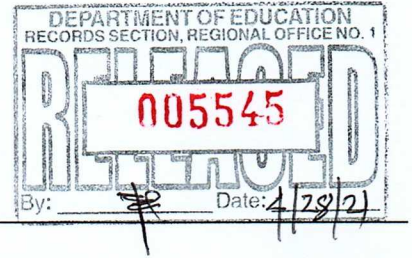

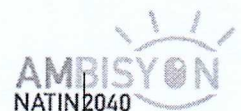

NATIONAL OFFICE MEMORANDUM

Number 23 series 2021

TO : Council Chairpersons, Council Scout Commissioners, Regional Scout Directors, Council Scout Executives and Officers-In-Charge

SUBJECT : ONLINE 64TH ANNUAL NATIONAL COUNCIL MEETING (ANCM)

1. As provided in Article V, Section 1 of R.A. 7278, the National Council shall hold an Annual Meeting not later than 31 May of each year, at such time, date and place as may be determined by the National Executive Board for the purpose of receiving the annual reports of the officers, electing the regular members of the National Executive Board, ratifying any proposed amendments to the BSP Bylaws (if any) and transacting such any other business as may properly come before the meeting.
2. Pursuant to the Republic Act No. 11469, an Act Declaring the Existence of a National Emergency Arising from the COVID-19 Situation and a National Policy in connection therewith, and Authorizing the President of the Republic of the Philippines for a Limited Period and Subject to Restrictions, to Exercise Powers Necessary and Proper to Carry Out the Declared National Policy and for Other Purposes.
3. Subsequently, the said Act prohibits the conduct, attendance, organization and participation in any event that draw a huge number of attendees that includes the conduct of the Annual National Council Meeting.
4. In this connection, the National Executive Board (NEB) in its meeting on 18 February 2021 has approved the conduct of the **64th ANNUAL NATIONAL COUNCIL MEETING (ANCM) on 27-28 May 2021 through Online via Zoom.**
5. The official participants of the conference are the following:
 - a. National Executive Board Members
 - b. Regional Chairpersons and Regional Scout Commissioners
 - c. Council Chairpersons and Council Scout Commissioners

All Local Councils are advised to accomplish the Notice of Attendance with the **name and email address** of their respective Council Chairpersons, Council Scout Commissioners as official delegates and the Council Scout Executive as observer, and must be forwarded to National Office, BSP through mail or electronic mail to charliecameros@gmail.com or ron.hontanosas@gmail.com on or 31 March 2021. The zoom link shall be sent to the conference participants before the meeting.
