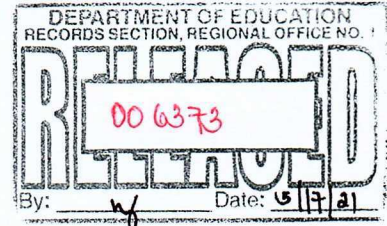

**SERIES OF TRAININGS ON LITERACY INSTRUCTION**

To: Schools Division Superintendents

1. The Department of Education Regional Office 1 (DepEd RO1) in partnership with World Vision-Philippines shall conduct a series of trainings on literacy instruction for teachers and instructional supervisors via Zoom Meeting Room on the following dates:

2. The trainings on literacy instruction generally aim to provide fundamental literacy pedagogy information supplemented by sessions that shall deepen participants' technical knowledge of language and reading and hone their talent and skills as educators or instructional supervisors.


