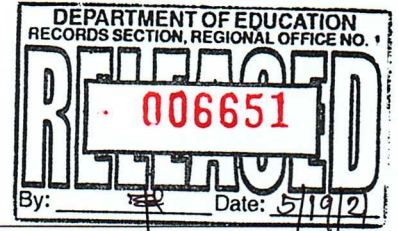

**SUPPLEMENTARY GUIDELINES IN THE UTILIZATION OF  
ADDITIONAL DOWNLOADED FUNDS FOR THE PROVISION OF  
Q4 LEARNING RESOURCES OF SY 2020-2021**

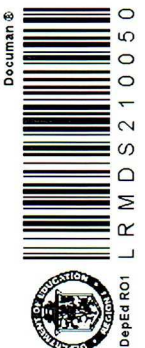
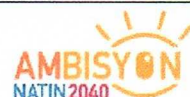
To: **Schools Division Superintendents**

1. DepEd Order No. 18, s. 2020 provided the guidelines for the release and utilization of funds for the provision of learning resources in light with the implementation of the Basic Education Learning Continuity Plan (BE-LCP).
2. Subsequently, DM-OUF-2020-0614 was issued to clarify DepEd Order No. 18, s. 2020 which enumerates the list of eligible activities that may be charged against the funds downloaded to the field for the provision of the learning resources for the implementation of the BE-LCP.
3. The release and use of the said funds shall be guided by the above-mentioned issuances with the following specific instructions:
  - a. The fund shall be utilized for the procurement for printing and delivery of SLMs for Quarter 4 for SY 2020-2021 and shall be subject to the minimum technical standards as prescribed under DM-CI-2020-00245; and
  - b. The fund may also be utilized for the procurement of Universal Serial Bus or other similar storage devices or purchase of tablets, subject to the limitations prescribed under Memorandum No. OUF-2020-0164.
  - c. Any balance of funds from the procurement of the above-mentioned learning resources may be used for the procurement or production of other learning resource requirements, including delivery costs of learning resources for the succeeding quarters for SY 2021-2022, as prescribed in Section 6.6 of D.O. 18, s. 2020.
4. This fund shall supplement the previously downloaded fund specified in DM-OUCI-2021-060 dated March 10, 2021. Other funding sources for this purpose were enumerated in the memorandum just cited.
