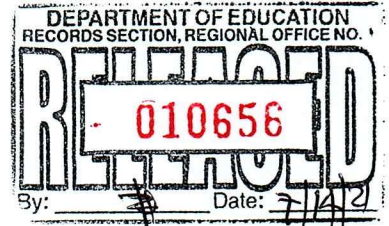

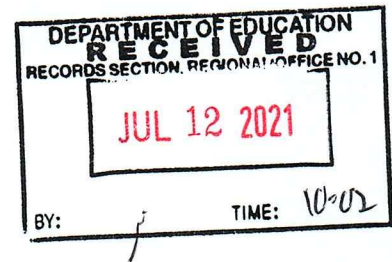

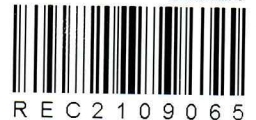

In line with last year's conduct of the 2020 National Teachers' Month (NTM) and the National/World Teachers' Day (NTD/WTD) celebrations anchored on the theme, "*Gurong Filipino para sa Batang Filipino*," the External Partnerships Service-Special Events Unit (EPS-SEU) downloaded funds for the conduct of said events to all Schools Division Offices (SDOs) nationwide.

The 2020 NTM/NTD/WTD were hosted by DepEd Regional Office I and the City Schools Division of San Fernando on October 10, 2021. The celebrations are pursuant to Presidential Proclamation No. 242 titled "Declaring the Period from September 5 to October 5 of Every Year as National Teachers' Month," as well as Republic Act No. 10743 titled "An Act Declaring the Fifth Day of October of Every Year as National Teachers' Day" and its Implementing Rules and Regulations (IRR).

In this regard, all SDOs that conducted the NTM/NTD/WTD celebrations are enjoined to submit a report on the expenses incurred during the said events for liquidation purposes. Said report must be submitted to EPS-SEU on or before the last week of July 2021.
