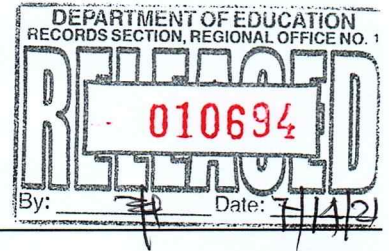

**DISSEMINATION ON THE OPENING OF CLASSES OF THE PRIVATE SCHOOLS  
AND NON-DEPED PUBLIC SCHOOLS, ISSUANCE OF GOVERNMENT PERMIT  
AND PROVISIONAL COMPLIANCE CERTIFICATE TO PRIVATE SCHOOLS FOR  
SY 2021 – 2022**

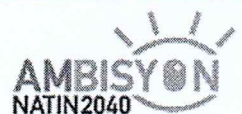
To: **Schools Division Superintendents**  
**Assistant Schools Division Superintendents**

1. This pertains to DepEd Advisory to Private Schools and Non-DepEd Public Schools on School Opening for SY 2021 – 2022 dated June 23, 2022. This Office, through the Quality Assurance Division (QAD) announces that Private Schools and Non-DepEd Public Schools may already start their classes for SY 2021 – 2022, provided that there are no face-to-face classes, and that the school will be strictly implementing only distance learning modalities.
2. All schools which operated for SY 2020 - 2021 and will operate this SY 2021 – 2022 are required to apply for the renewal of government permit to operate basic education courses. For schools which are operating without Provisional Compliance Certificate (PCC) are required to submit Letter of Intent (LOI) indicating the type of learning delivery modality/ies to be offered.
3. Private Schools with Provisional Compliance Certificate (PCC) issued last SY 2020 – 2021 are no longer required to apply this SY 2021 – 2022, except those schools which will offer additional and/or change of learning delivery modality/ies.
4. Private Schools and Non-DepEd Public Schools intending to start their classes ahead of the general school opening will submit the relevant documents to the Regional Office as stipulated in DO No. 013 and 017, s 2021 on readiness assessment. The deadline for the submission of complete documentary requirements including the date of opening of classes with the attached school calendar of activities for SY 2021 – 2022 will be **fifteen (15) days** before the opening of classes.
5. The SDOs will evaluate and ensure that all requirements are met before the said application is forwarded to the Regional Office for action.

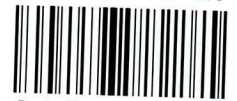
