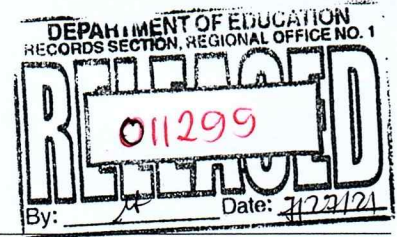

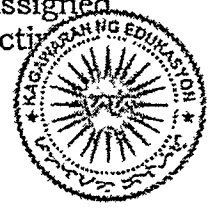

In order to strengthen the necessary structures and processes for effective program implementation of the transfer, the following are to be undertaken immediately:

1. Current Program Coordinators shall turn over the necessary documents and other pertinent information to the new assigned managing division under the CI Strand. All other programs and activities relative to Career Guidance shall be handled/implemented by the new assigned managing division after the completion of the turnover of materials.
2. Each division shall continue with the conduct of the activities related to Career Guidance planned under their 2020 work plans. Budgetary requirements are to be looked into and transferred to the new assigned managing division under the CI Strand for inclusion in their activities and plans for 2021.
