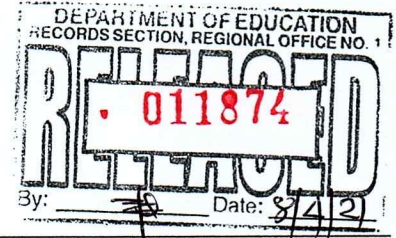

**KNOWING MY RIGHTS: THE ROLE OF SCHOOL GENDER AND DEVELOPMENT (GAD) ADVOCATES IN THE IMPLEMENTATION OF GAD-RELATED LAWS**

To: Schools Division Superintendents

1. The Department of Education Regional Office 1, through the Human Resource Development Division (HRDD), shall conduct a three-day training on **Knowing My Rights: The Role of School GAD Advocates in the Implementation of GAD-related Laws** on **September 13-15, 2021** (Batch 1) and **September 28-30, 2021** (Batch 2) at the National Educators Academy of the Philippines Region I (NEAP-RI), San Vicente, City of San Fernando, La Union.

2. The training aims to develop among the participants the strong sense of self-worth as a human person and genuine respect for others, broaden understanding on the provisions of laws that uphold human rights, and contribute to gender equality in the workplace and in the society where every human being should enjoy that equal access to resources and opportunities regardless of gender.


