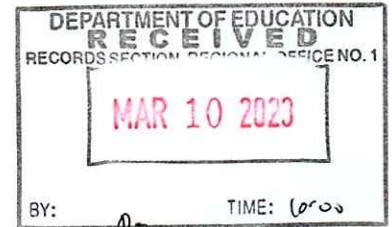

BACKGROUND INFORMATION

Republic Act (RA) No. 11650 known as the "Instituting a Policy of Inclusion and Services for Learners with Disabilities in Support of Inclusive Education Act" aims to provide learners with disabilities (LWDs) free and appropriate public early and basic education and support and related services based on their needs, and in preparation for independent living and community life.

The Act states that the Department of Education (DepEd) in collaboration with Local Government Units (LGUs), shall initially establish and maintain at least one (1) Inclusive Learning Resource Center (ILRC) in all cities and municipalities.

Prelude to the passage of RA 11650 on March 11, 2022, the DepEd took the initiative to convert the 16 SPED Centers into ILRC through DepEd Order No. 45, s. 2021 Policy Guidelines in the Selection of Minimum Requirements for the Conversion of Certain SPED Centers into Prototype Inclusive Learning Resource Centers.

The DepEd through the Bureau of Learning Delivery-Student Inclusion Division (BLD-SID) had downloaded support fund during Fiscal Year (FY) 2021 and 2022 to 16 select SPED Centers. The 16 ILRCs will serve as models of the remaining ILRC for every city and municipality in the country.

Another, DepEd is providing Program Support Funds (PSF) to regions and divisions to augment the needs in managing and implementing Special Needs Education (SNEd) programs. DepEd Order No. 42, s. 2021 Guidelines on the Utilization of Program Support Funds for Special Education Program provides directions on the eligible expenses needed for the SNEd programs:

1. Formal assessment or rehabilitation of LWDs by medical or allied specialists
2. Acquisition of specialized materials, devices, and equipment that are intended for instructional purposes of learners with disability/difficulty.
3. Attendance of SNEd teachers and receiving teachers and other concerned school personnel in specialized trainings on inclusive and special education conducted by NEAP accredited service providers.
4. Immersion of LWDs to different work industry for possible employment and their participation to sports, academic and co-curricular activities toward holistic development.
5. Communication expenses of SNEd implementers subject to reimbursement and/or liquidation and existing DepEd policy on communication expense.

ONLINE MONTHLY MEETINGS WITH THE SPED REGIONAL AND DIVISION FOCAL PERSONS, AND ILRC COORDINATORS

Monitoring and evaluation is an integral part of program management and implementation. It is a shared responsibility among implementers and is built into their roles in managing and implementing programs.

Thus, the BLD-SID shall conduct online monthly meetings with the SPED Regional and Division Focal Persons and ILRC Coordinators with the following objectives:

1. Monitor the progress of the conversion of SPED Centers into ILRCs
2. Conduct strategic planning for the identification of the remaining ILRC for each region.
3. Identify the opportunities and challenges encountered in the conversion and operation of ILRC.
4. Identify the opportunities and challenges in managing SNEd programs like downloading of PSF, SNEd teaching items, and others.

The SPE regional and division focal persons and ILRC coordinators are expected to provide data on the physical and financial accomplishment in terms of refurbishing or repairing rooms to create the following support service areas.

1. Assessment service area
2. Physical therapy service area
3. Occupational and behavioral therapy service area
4. Speech and language therapy service area
5. Bridging service area
6. E-Library
7. Management service area
8. Daily living skills area
9. Skills development area
10. Water/Hydrotherapy area

There will be monthly meetings to continuously track the progress of program implementation of the following:

1. Tagging of LWDs in the LIS/EBEIS
2. Utilization of Program Support Funds
3. Updates on the conversion of SPED centers into ILRCs

4. SNEd Items
5. Others

With the conduct of online monthly meetings, the utilization of downloaded funds shall be managed efficiently and effectively. The utilization of funds for ILRCs and SNEd programs can be tracked properly. Also, SNEd concerns will be discussed so that technical assistance can be provided.
