1. Pursuant to DepEd Order No. 15 s, 2012 also known as the Policy Framework for the Implementation of Alternative Dispute Resolution (ADR) System-Mediation, this Office recognizes thirty (30) personnel of DepEd Region I who successful completed the 80-hour classroom and internship program conducted by this Office through the Conflict Resolution (CoRe) Group. As provided under the same DepEd Order, all DepEd officials and employees in the Central, Regional and Division Offices who have completed the classroom training and internship on mediation conducted by the DepEd through the Conflict Resolution (CoRe) Group shall comprise the roster of mediators.
