Furthermore, for the secondary level where there is a separate Registry of Qualified Applicants (RQA) per subject area or specialization, qualified beneficiaries shall also be given priority before all other qualified applicants for the same subject area or specialization.

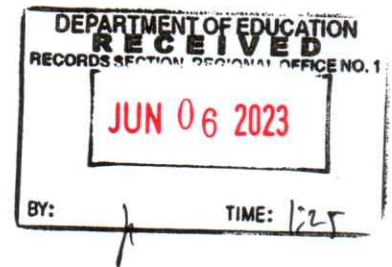
