RESOLUTION NO. 2023-10-65

RECOMMENDING APPROPRIATE ACTION IN THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF SCHOOL FURNITURE FOR ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS UNDER THE BASIC EDUCATIONAL FACILITIES FUND (BEFF) SCHOOL FURNITURE PROGRAM CY 2022 AND 2023

FOR RESOLUTION by the Bids and Awards Committee (BAC) is the request for appropriate action on the opening and submission of bids for the Supply and Door-To-Door Delivery of School Furniture for Elementary, Junior and Senior High Schools under the Basic Educational Facilities Fund (BEFF) School Furniture Program CY 2022 and 2023.

On September 11, 2023, the BAC and the end-user conducted a pre-procurement conference discussing the details of the upcoming procurement activity. Eventually, the BAC caused the said procurement activity to be published on the PHILGEPS Website, the DepEd Region I Website and in conspicuous areas in the Regional Office proper.

The pre-bid conference was conducted on September 19, 2023 at 1:30 in the afternoon at the Conference Room of this Office. The submission and opening of bids is scheduled on October 3, 2023. During the pre-bid conference, Engineer Celso C. Manangan, a Technical Working Group (TWG) member, thoroughly discussed the technical specifications as well as the design of the school furniture, pictures of the same were shown for reference.

However, the End-User Unit and the Technical Working Group requested for an urgent meeting with the Bids and Awards Committee members and its secretariat. It was revealed that there was inadvertence in the posting of technical specifications and drawings attached to the bidding documents posted on the PHILGEPS Website and DepEd Region I Website. The specifications and drawings were dated 2021 and not the appropriate design for 2022 and 2023.

Considering that the proper designs and technical specifications are material to the success implementation of the procurement activity, correction of the same is necessary.

The Bids and Awards Committee further resolved to recommend to the Head of Procuring Entity appropriate action to prudently provide information to the prospective bidders as to the requirements of items subject of the procurement.


WHEREFORE, premises considered, the BAC resolved to:

1. Recommend the cancellation of any ensuing procurement activity to the abovementioned project;

2. Recommend to the Head of Procuring Entity to adopt appropriate measure based on the Revised Implementing Rules and Regulations of Republic Act 9184.
