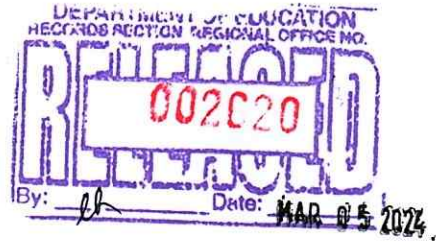

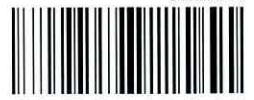

REGIONAL UPSKILLING OF ENGLISH TEACHERS IN LANGUAGE INSTRUCTION

To: Schools Division Superintendents

1. In line with the commitment of the Department of Education (DepEd) outlined in the MATATAG Agenda to *give support to teachers to teach better*, the Department of Education Regional Office I through the Curriculum and Learning Management Division shall conduct the **Regional Upskilling of English Teachers in Language Instruction** on **March 12-15, 2024** in a hotel in Region I. The specific venue will be announced in a separate memorandum.
2. The activity has the following objectives:
 - a. Facilitate high-quality professional learning opportunities to ensure that English teachers are competent in teaching the standards and proficient in using the target language; and
 - b. Devise teaching strategies and techniques that develop learners' communicative language competence.
3. In this light, this Office requests SDOs to identify elementary and secondary master/head teachers of English and/or subject group heads of HUMSS who shall participate in the activity. Please refer to *Enclosure 1* for the details. Participants shall pre-register through this link: tinyurl.com/RegFormUpskillingELR1 on or before February 23, 2024.
4. DepEd Order No. 9, s. 2005 otherwise known as "*Instituting Measures to Increase Time-on-Task and Ensuring Compliance Therewith*" shall be observed during the conduct of the activity. Thus, school heads of the identified teacher-participants shall employ strategies and develop contingency plan to guarantee uninterrupted classes, demonstrating proactive measures to address potential disruptions.
5. Participants and facilitators shall be granted 15 CPD units subject to completion of the training and submission of outputs.
6. The list of learning facilitators/members of the Program Management Team is found in *Enclosure 2*. SDOs are requested to facilitate their attendance in the activity.
