4. The RSAC shall be responsible, among others, for the evaluation and verification of the authenticity of the documents submitted by the athletes, coaches, and chaperones applying for accreditation. It shall also accredit qualified athletes, coaches, and chaperones, and submit a master list to the R1AA before the conduct of the Regional Meet. **STRICTLY NO REPRESENTATIVE or SUBSTITUTE RSAC Member is allowed.**

5. The food and accommodation of RSAC Members during the conduct of validation of documents and interview of ACCs shall be shouldered by CO downloaded funds while the transportation vehicle of the RSAC members to various Schools Divisions are to be shouldered by the host Division. All other expenses during the screening proper shall be charged against the CO downloaded funds subject to usual accounting and audit rules.
