CONCURRENCE TO RECEIVE PROGRAM SUPPORT FUNDS (PSF) FOR THE IMPLEMENTATION OF THE NATIONAL LEARNING CAMP (NLC) AND OTHER END OF SCHOOL YEAR (EOSY) BREAK ACTIVITIES

To: All Schools Division Superintendents
 All Others Concerned

1. The Department of Education (DepEd) is currently strengthening the implementation of the National Learning Camp (NLC), which is integral to the overarching National Learning Recovery Program (NLRP), encompassing a three (3)-to five (5)-week voluntary program for the three camps.

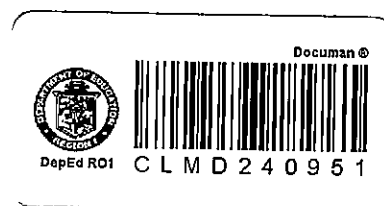
