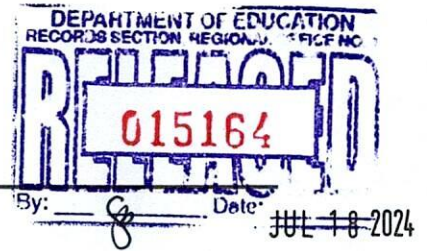

**REITERATION OF REGIONAL MEMORANDUM NO. 609, S. 2023 TITLED “NON-COMPLETION OF LINKING STANDARDS AND QUALITY PRACTICE (LiSQuP) SCHOLARSHIP PROGRAM”**

To: Schools Division Superintendents  
  
Chief of Functional Division  
Human Resources Development Division

1. This is to reiterate that the Linking Standards and Quality Practice (LiSQuP) Scholarship Program is still ongoing and scholars who submit intent to withdraw from the program should adhere to the stipulations of DM 82, s. 2020:

*“g. refund in full to DepEd such sums of money as may have been defrayed by the Philippine government for expenses incidental for having attended the program or course, for failure to comply with any of the foregoing conditions through my fault or willful neglect, resignation from the service, transfer to other agencies, voluntary retirement or other causes within my control. For reasons beyond the control of the teacher-participant, the conditions do not apply, provided that all documentary requirements including doctor’s certification are met and are acceptable to DepEd.”*

2. As such, scholars who fail to complete the program due to causes within his/her control must pay in full the Department of Education (DepEd) through the National Educators Academy of the Philippines (NEAP).

3. The amount to be paid for the Doctorate or Master’s Degree Programs is as follows:

- PhD – Php 150, 000.00
- MA – Php 120, 000.00

4. Payments shall be made through the Accounting Office of the Schools Division and shall then be forwarded to the Bureau of Treasury. Indicate in the receipt “Payment for LiSQuP Scholarship.”

5. Scholars who cannot pay in full shall coordinate or decide with the SDO/Regional Office through a Promissory Note attached in this Memorandum.
