1. In reference to DM-CT-2024-242, the Department of Education-Office of the Undersecretary for Curriculum and Teaching through the Curriculum and Learning Management Division requests the assistance of the Schools Division Offices to facilitate the completion of the survey questionnaires to be accomplished by the Learning Camp Volunteers (LCVs) and School Heads National Learning Camp (NLC) participating schools.

2. The survey tool can be accessed through the Learning Management System (LMS) using the URL assigned to the region provided in Annex A, guided by the reminders below:

a. **One-time Official Access:** Only the official respondents shall access the portal and accomplish the survey questionnaires. This is to avoid the duplication of responses, thus maintaining the validity and reliability of the survey. The official respondents are the School Heads and LCVs of NLC participating schools.

b. **Single Response:** All official respondents shall complete the survey questions only once.

c. **Complete Responses:** Respondents shall answer each question one after the other. Every question is a prerequisite to the next.

d. **Certificate Generation:** Certificates for LCVs and School Heads shall be generated upon the successful completion of the survey. The generation of the certificates is open from July 19, 2024 to August 19, 2024 only.

3. All LCVs who handled NLC classes shall receive a Certificate of Recognition and a Certificate of Learning and Development, while those who taught Remedial Classes shall receive a Certificate of Recognition as teacher volunteers.

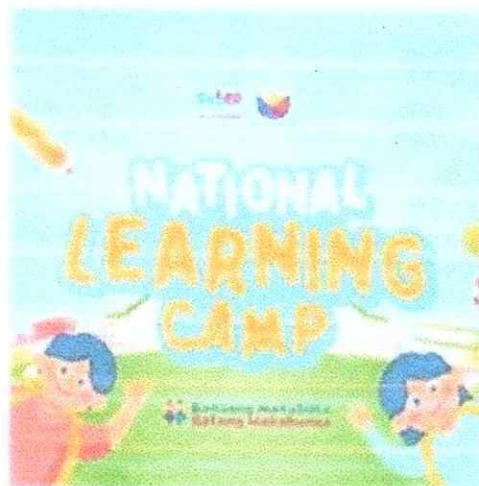

- Completely answer all items that appear in the survey tool.

4. Download Certificate

- After responding to all items in the survey tool, download the certificate/s.

5. Print and facilitate the school head's signature on the certificate

- Print the certificate/s.
- NLC LCVs shall request their respective school heads to sign their certificate of recognition and learning and development, indicating the number of volunteer hours.
- Teacher Volunteers in the Remedial Classes shall request their respective school heads to sign their certificate of recognition indicating the number of volunteer hours.
