**INVITATION TO BID FOR**  
**Supply and Door-to-Door Delivery of Supplementary Learning Resources (SLRs) for Library Hubs in Region I**

1. The Department of Education, through the GAA FY 2024 intends to apply the sum of **Twenty-Six Million Six Hundred Fifty-Nine Thousand Eight Hundred Twenty-Nine Pesos and Twenty-Three Centavos (₱26,659,829.23)**, corresponding to all lots and being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Door-to-Door Delivery of Supplementary Learning Resources (SLRs) for Library Hubs in Region I**. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

\*The project is separated into **TWENTY-THREE (23) LOTS** which will be awarded into separate contracts, bidders are required to purchase and submit Bid Documents per lot.

2. The *Department of Education Regional Office I, City of San Fernando, La Union* now invites bidders (suppliers, distributors, publishers) accredited/registered with National Book Development Board to bid for the above procurement project. Delivery of Goods is required within sixty (**60**) calendar days from receipt of Notice to Proceed for each lot. Bidders should have completed, within **five years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

3. A complete set of Bidding Documents may be acquired by interested Bidders on **August 9, 2024 to August 28, 2024 until 10:00 in the morning** from the given address or website and upon payment of the applicable fee. The prospective bidders shall pay the fees in person at the Cash Unit or electronically through **DepEd RO-1 Remittances and other Funds with Land Bank Account Number 0202-0256-41**. Deposit Slip should be scanned and emailed to [bac.region1@deped.gov.ph](mailto:bac.region1@deped.gov.ph).

4. The **Department of Education Regional Office I, City of San Fernando, La Union** will hold a **Pre-Bid Conference** at its **Conference Room** on **August 16, 2024 at 2:30 in the afternoon** and/or through video conferencing via **GOOGLE MEET** which shall be open to prospective bidders. The link shall be provided upon request by the prospective bidders.

5. Bids must be duly received by the BAC Secretariat through manual submission at the **Executive Conference Hall, DepEd Regional Office I, City of San Fernando, La Union, DepEd Regional Office I, City of San Fernando, La Union**, on or before **10:00 in the morning of August 28, 2024**. Late bids shall not be accepted.

6. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

7. **Bid opening** shall be on **August 28, 2024, 10:00 in the morning for Lots 1-10 and August 29, 2024, 9:00 in the morning for Lots 11-23** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity personally or online through a link that will be provided upon request.

8. The **Department of Education Regional Office I, City of San Fernando, La Union** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
