

The Department of Education (DepEd), through this Office, reiterates the guidelines outlined in the **Joint Circular No. 2, s. 2020** titled *Addendum No. 2 [Clarification to DepEd-DBM-DILG Joint Circular No. 1, series of 2017 dated January 19, 2017, entitled, "Revised Guidelines on the Use of the Special Education Fund (SEF)"]* issued by the Department of Education (DepEd), Department of Budget and Management (DBM), and Department of Interior and Local Government (DILG) relative to the utilization of the Special Education Fund (SEF) on the acquisition of learning resources (LRs).

Provisions as provided in the Joint Circular shall be observed in the use of the SEF that shall be utilized for the procurement of LRs.

The DepEd field offices are reminded to strictly adhere to the following guidelines set which clarifies allowable expenses chargeable against the SEF:

Accordingly, the following expenditures are hereby clarified as allowed to be charged against the SEF, net of whatever DepEd may provide for similar expenses through its own budget and subject to the provisions of item 5.0 of DepEd-DBM-DILG JC No. 1, s. 2017 dated January 19, 2014

2.1 Operation and maintenance of public schools

2.1.1 Payment for the costs and expenses in connection with the acquisition, production, reproduction, and printing of learning materials for the learners such as self-learning modules, textbooks, activity sheets, and study guides/manuals approved by DepEd.
