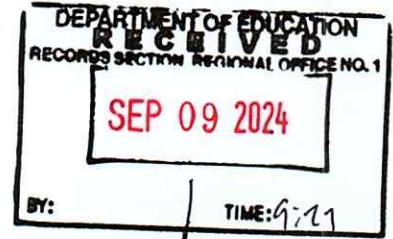

The Universal Health Care Act (UHC) aims to “ensure that all Filipinos are guaranteed equitable access to quality and affordable health care goods and services and protected against financial risk.” Pursuant to this, the Philippine Health Insurance Corporation (PhilHealth) adopted a comprehensive approach in delivering primary and preventive care through the development of PhilHealth Konsultasyong Sulit at Tama (Konsulta) Package. Through this, members and their dependents registered to any Konsulta provider of their choice are eligible to avail of consultation, health risk screening and assessment, selected laboratory and diagnostic test, and selected drugs and medicines free of charge.

The Department of Education, staying true to its commitment of promoting and protecting the general welfare and holistic well-being of its employees, is taking initial steps to have all existing DepEd clinics accredited as PhilHealth Konsulta Package Providers (KPP). This initiative will enable all DepEd teaching and non-teaching personnel to enjoy the benefits outlined in the program with the maximum capita amount at Php 1,700.00 per patient per year.

A face-to-face consultation is underway to assess the readiness of DepEd clinics for KPP accreditation. This information will serve as reference for the feasibility required
