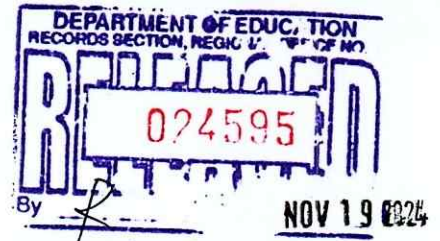

ORIENTATION ON THE UTILIZATION OF MATHEMATICS LEARNING RESOURCES (MANIPULATIVE MATERIALS)

1. The Regional Office through the Curriculum and Learning Management Division will conduct the Orientation on the Utilization of Mathematics Learning Resources in La Union on November 22-24, 2024 (Batch 1) and November 24-26 2024 (Batch 2).
2. Anchored on the MATATAG Agenda, by virtue of DepEd Order No. 13, s. 2023 the activity aims to:
 - a. equip the participants on how to maximize learning resources that simplify complex concepts, introduce innovative teaching methods, and improve student engagement; and
 - b. provide them with strategies and techniques for effectively incorporating learning resources into their daily lessons, improving instructional delivery, learning engagement, and classroom management in mathematics.

In this connection, this Office requests the participation of the division Education Program Supervisor in-charge of Mathematics, Public School District Supervisors, Elementary School Heads and Mathematics Coordinator to the activity. All participants are requested to bring a set of the distributed Mathematical Learning Resources (Manipulative Materials) and shall accomplish the online Registration and Attendance templates not later than November 20, 2024.
