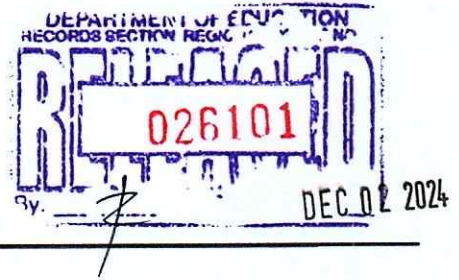

**2024 NATIONAL LITERACY CONFERENCE AND AWARDS**

To: Schools Division Superintendents

1. The Department of Education, through the Literacy Coordinating Council (LCC) will conduct the 2024 National Literacy Conference and Awards with the theme, "Cultivating Literate and Peaceful Communities: Practices, Partnerships and Pathways" on December 10- 13, 2024 (inclusive of travel time) at the Waterworld Hotel, Mandaue City, Cebu to be live-streamed simultaneously on DepEd Philippines and LCC's Facebook Pages.

2. The activity aims to:
- a. create platform for sharing best practices on literacy programs;
  - b. amplify partnerships and engagement with key stakeholders in implementing community -based literacy programs;
  - c. harvest policy recommendations focused on building pathways to advance literacy for all; and

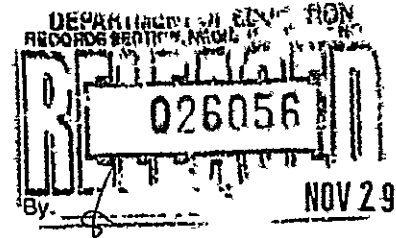
