SUBJECT : IMMEDIATE FILLING UP AND SUBMISSION OF REASONS FOR
THE UNFILLED SPECIAL EDUCATION TEACHER ITEMS

DATE : 29 November 2024

This has reference to the proposal of the Bureau of Learning Delivery for additional allocation of Special Education Teacher (SPET) Items to schools with Learners with Disability. Please be informed that the request for the creation of additional SPED teaching items shall be considered in the FY 2025 allocation, subject to the availability of funds and the approval of the Department of Budget and Management (DBM).

In addition, it was also noted that based on the Government Manpower Information System (GMIS) of the Department of Budget and Management, as of 13 September 2024, there are six hundred eighty-five (685) unfilled items out of the six thousand two hundred sixty-seven (6,267) total authorized SPED teaching items (Annex A).

In this regard, concerned Schools Division Offices are requested to immediately fill up these items to partly augment the teacher needs in schools. It is also requested that reasons for the unfilled items be submitted to serve as inputs in the refinement of policies regarding the deployment of SPET items.
