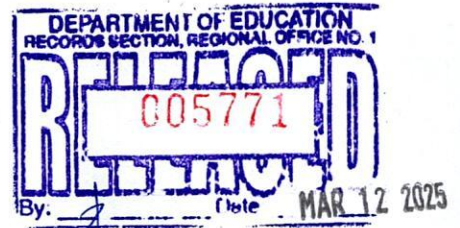

1. The Career Executive Service Board (CESB), in partnership with the National Commission for Culture and the Arts (NCCA), will be holding the first semester 2025 CES Club under the theme: **"Lugom Dayaw: Tinalak-Habi ng Pagkakakilanlan, Kamalayan at Kasaysayan"** in the **Municipality of Lake Sebu, Province of South Cotabato** on **March 26-27, 2025**.

2. The activity aims to feature the *"Dream Weavers of Lake Sebu"*, the women behind the *T'nalak* cloth weaving, and promote awareness and experience the rich culture and history of *T'boli* women and the role of weaving in empowering women in the community through classroom sessions and tours.

3. There shall be a registration fee of **₱5,000.00**, which shall be charged for overnight accommodation, snacks, meals, tour transport services, entrance fees, and a study tour kit. The said fee may be paid in cash, check, or through LDDAP payable to **Career Executive Service Board** using **Landbank of the Philippines (LBP) Account Number: 0622-1022-34**.

Failure to cancel attendance on or before the said date will compel CESB to bill the registered participant in full amount (₱5,000.00) of the Registration Fee.


