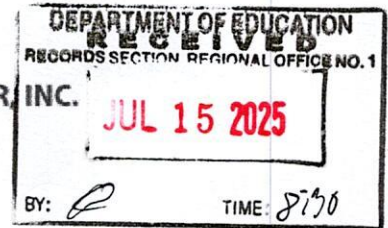

As defined in **Section 3(D) of NPC Circular 18-02**, a **Compliance Check** is a systematic evaluation of a Personal Information Controller (PIC) or Personal Information Processor (PIP) to determine if personal data is processed in accordance with the **Data Privacy Act (DPA)** and other NPC issuances.

Workshop Objectives:

This session aims to help both public and private organizations understand:

- NPC guidelines on conducting compliance checks
- Modes and timing of compliance checks
- Key principles of the **General Data Protection Regulation (GDPR)** and the **Philippine Data Privacy Law**

Discussions will be led by **Data Privacy Managers, PECB ISO/IEC 27701 Lead Auditors**, and other privacy experts.

Important Reminders:

- **Non-compliance** with a Compliance Order (Section 12, NPC Circular 18-02) may lead to **criminal, civil, or administrative penalties**.
- **NPC Circular 2021-01** authorizes administrative fines of **1% to 5% of annual gross income** for violations, depending on the severity and frequency of infractions.
