

To provide clear and proper guidance to the parents and guardians of learners who intend to enroll in private schools or already enrolled in private schools, Section 30 of DepEd Order No. (DO) 88, s. 2010, as amended by DO 11, s. 2011, mandated the schools, Division, and Regional Offices to:

- 1. Schools post a copy of their permit/s or recognition of programs in bulletin boards located inside their campuses; and
- Regional and Division Offices post in their bulletin boards a list of schools granted with the authority to operate.

In order to further cascade and inform the general public on the matter, all Regional and Division Offices are directed to post the list of private schools authorized to operate in conspicuous places such as bulletin boards, information desks, and the official websites of the Region and Divisions, on or before August 8, 2025. The list shall be regularly updated, whenever applicable.


