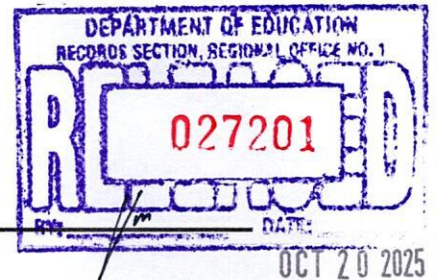

**ADDENDUM TO THE REGIONAL MEMORANDUM NO. 1362 S. 2025
(CONDUCT OF MONITORING AND EVALUATION FOR THE

K TO 12 CURRICULUM IMPLEMENTATION)**

To: Schools Division Superintendents

1. This is in reference to Regional Memorandum No. 1362 s. 2025, titled "Conduct of Monitoring and Evaluation for the Training of School Leaders on the Revised K to 12 Curriculum Implementation," relative to the inclusion of the following monitoring focal from SDO San Carlos City and Urdaneta City as indicated below.

2. Service Credits or Compensatory Time-Off (CTO) shall be granted to the participants if the activity falls on holiday, weekend, cancellation or suspension of classes and work in Government Offices due to typhoons, flooding, other weather disturbances, and calamities pursuant to the guidelines specified in DepEd Order No. 13, s. 2024 on the Revised Guidelines on Grant of Vacation Service Credits to Teachers and CSC-DBM Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Services Rendered, whichever is appropriate and applicable.

3. Travel and other miscellaneous expenses related to the conduct of the monitoring activities shall be charged against the 2025 Human Resource Development (HRD) Funds. In case downloaded funds are insufficient, it can be charged to the SDO/School MOOE or local funds subject to usual accounting and auditing rules and regulations.

4. All other provisions of the Memorandum shall remain in effect.
