> GUIDELINES ON THE UTILIZATION OF FISCAL YEAR 2024 CONTINUING APPROPRIATIONS AND FISCAL YEAR 2025 CURRENT APPROPRIATIONS BALANCES TO SUPPORT TEACHING AND LEARNING FOR KEY STAGE I

To: Schools Division Superintendents

- Relative to the utilization of FY 2024 Continuing Appropriations and FY 2025 Current Appropriations, the Department of Education (DepEd) issues Joint Memorandum titled "Guidelines on the Utilization of Fiscal Year 2024 Continuing Appropriations and Fiscal Year 2025 Current Appropriations Balances to Support Teaching and Learning for Key Stage I," to provide guidelines on the use of balances of unobligated Program Support Funds (PSF) which were downloaded and/or directly released to Regional Offices (Ros) for the implementation of programs, activities, and projects (PAPs) from FY 2024 Continuing Appropriations and FY 2025 Current Appropriations.
- 2. Balances from the said funds shall be used to support teaching and learning for Key Stage 1 (KS1), in accordance with DepEd Order No. 28, s. 2025 entitled "Guidelines on the Use of Balances from Fiscal Year 2024 (Republic Act No. 11975) Funds Under the Learning Systems Strand", and DepEd Order No. 27, s. 2025 entitled "Guidelines on the Use of Balances from Fiscal Year 2025 (Republic Act No. 12116 Funds Under Learning Systems Strand.
- 3. The said Joint Memorandum provides guidelines for the use of Program Support Funds for the following: (1) printing and delivery of story books; (2) supply and delivery of big books; (3) printing and delivery of leveled readers; (4) and development of structured pedagogy lesson guides. These initiatives aim to enhance literacy instruction and ensure that KS1 learners have continuous access to quality learning resources both in and out of the classroom.
- 4. Refer to the attached Joint Memorandum for the fund sources and releases related to the provision of support for KS1, specific directives for reprioritization by specific PAP, validity of the funds, technical specifications, fund utilization, and monitoring of implementation activities related to this purpose.



- 1. The Department of Education (DepEd) issues this memorandum for the use of balances of unobligated Program Support Funds (PSF) which were downloaded and/or directly released to Regional Offices (ROs) for the implementation of programs, activities, and projects (PAPs) from Fiscal Year (FY) 2024 Continuing Appropriations and FY 2025 Current Appropriations. These balances shall be used to support teaching and learning for Key Stage 1 (KS1), in accordance with DepEd Order No. 28, s. 2025 entitled "Guidelines on the Use of Balances from Fiscal Year 2024 (Republic Act No. 11975) Funds Under the Learning Systems Strand", and DepEd Order No. 27, s. 2025 entitled "Guidelines on the Use of Balances from Fiscal Year 2025 (Republic Act No. 12116) Funds Under the Learning Systems Strand".
- 2. KS1 marks the initial developmental milestone in the K to 12 Program and serves as a crucial foundation for building essential literacy skills. During this stage, learners begin to develop phonological awareness, phonics, vocabulary, fluency, and comprehension. However, without sufficient instructional support and appropriate learning resources, learners may face significant challenges in acquiring these foundational competencies.
- 3. Additionally, KS1 learners are especially vulnerable to learning loss when classes are disrupted by disasters or other emergency situations. These interruptions result in loss of instructional time and contribute to delays in the development of













foundational literacy skills. As such, flexible learning opportunities become essential to ensure continuity in literacy development beyond regular class hours and outside the traditional classroom setting.

- 4. To further strengthen the implementation of KS1 and address these challenges, this Memorandum provides guidelines for the use of PSF for the following: (1) printing and delivery of storybooks; (2) supply and delivery of big books; (3) printing and delivery of leveled readers; (4) and development of structured pedagogy lesson guides. These initiatives aim to enhance literacy instruction and ensure that KS1 learners have continuous access to quality learning resources, both in and out of the classroom.
  - a. Storybooks and big books provide an engaging and accessible medium for learners to practice reading, expand vocabulary, and develop comprehension strategies independently or with minimal guidance from teachers or parents. Regular exposure to these resources can help mitigate potential learning gaps that may arise from various learning environments of KS1 learners.
  - b. Leveled readers provide a gradual and systematic approach to developing reading fluency and comprehension. These are designed to match learners' reading levels. These carefully crafted and organized books are designed to ensure that learners are neither overwhelmed nor frustrated. These help encourage a love for reading, build confidence, and set the stage for future learning.
  - c. Reading Nook is a designated, comfortable space within classrooms or school spaces that encourages independent reading. It provides learners with access to a variety of age- and level-appropriate reading materials, including storybooks, big books, and leveled readers. It also supports flexible learning opportunities and ensures all learners have access to quality reading experiences. The reading nooks shall have suitable storage containers for the reading materials and comfortable reading options like bean bags, puzzle mats or chairs.
  - d. **Structured pedagogy** is an educational approach that supports teachers in the implementation of the curriculum through clear lesson guides, aligned materials, and ongoing professional development. DepEd shall develop and disseminate structured pedagogy lesson guides as a focused and cost-effective way to strengthen teaching and learning in KS1.

- The ROs shall ensure the implementation of the programs funded by FY 2024 Continuing Appropriations within thirty (30) days, and those funded by FY 2025 Current Appropriations within sixty (60) days.
- 8. The validity of the funds is as follows:

- a. FY 2024 Continuing Fund pursuant to Republic Act No. 11975 (FY 2024 General Appropriations Act [GAA] and National Budget Circular NBC No. 592 (Guidelines on the Release of Funds for FY 2024 dated January 2, 2024) must be obligated and disbursed on or before December 31, 2025.
- b. FY 2025 Current Fund pursuant to Republic Act No. 12116 (FY 2025 GAA) and NBC No. 595 (Guidelines on the Release of Funds for FY 2025 must be obligated and disbursed on or before December 31, 2026.
- 9. The technical specifications indicated in this Memorandum shall be strictly adhered to.
- 10. The Regional Directors (RDs) shall ensure the timely delivery of the storybooks, bigbooks, and leveled readers to the identified recipient Schools Division Offices (SDOs)/Districts/schools or other delivery drop-off points that they deem most appropriate and logistically efficient.
- 11. The PSF may be further downloaded to SDOs or schools, as applicable and cost-effective.

# Annex A - Guidelines for the Printing and Delivery of Storybooks, Supply and Delivery of Big Books, and Printing and Delivery of Leveled Readers

- 1. The technical specifications as provided in this Memorandum shall be observed in the use of the funds.
- 2. While the budget is available through the Regional Offices (ROs), the printing and delivery of storybooks, supply and delivery of big books, and printing and delivery of leveled readers shall be facilitated by the Schools Division Offices (SDO). The SDOs, in coordination with the recipient schools, shall determine the corresponding physical target of their respective allocation based on the breakdown of the budget.
- 3. The learning materials for KS1 can be a tool for independent and self-paced learning. This initiative shall directly address their foundational learning needs. It prioritizes the provision of tangible, developmentally appropriate, and age-specific storybooks that will encourage reading and support literacy development among KS 1 learners. Storybooks provide learners with the opportunity to build early reading habits, develop language proficiency, and foster a lifelong love of reading. The budget for this initiative covers the following:
  - a. For the printing and delivery of storybooks, schools shall select titles based on their needs, appropriateness to grade level, and suitability to learners. The list of titles that have been quality assured by DepEd can be accessed through this link: <a href="https://tinyurl.com/StorybookTitles">https://tinyurl.com/StorybookTitles</a>.
    - Furthermore, the amount allocated for operational expenses shall be utilized to purchase materials such as storage bins, plastic covers, art materials, decors, and others relative to the maintenance of reading nooks.
  - b. For the supply and delivery of big books, titles shall come from the list of supplementary learning resources (SLRs) identified, selected, and evaluated by the Regional Offices (ROs) specifically intended for Key Stage 1. DM-CT-2024-103 and DM-CT-2025-047 contain the existing list of SLRs.
  - c. For the printing and delivery of leveled readers, the list and copy of materials that have been quality assured by DepEd can be accessed through this link: https://tinyurl.com/LeveledReadersBook.
- 4. ROs and SDOs are hereby advised to immediately prepare and plan for the printing and delivery of storybooks and leveled readers as well as supply and delivery of big books in accordance with the identified allocation list upon receipt of funds.
- 5. The following considerations shall likewise be observed:

a. The activities to be funded shall be aligned with the goals and objectives of these guidelines.

b. The quantity of storybooks, bigbooks, and leveled readers to be printed shall be determined by the RDs based on the budget breakdown. Moreover, the quantity of the aforementioned materials provided should not fall below the set physical targets to ensure sufficient learning resources for KS1 learners.

- c. Any balance remaining from the amount shall be allocated to the printing and delivery of additional story books, supply and delivery of additional big books, printing and delivery of additional leveled readers for KS1, and other operational needs directly supporting program implementation. ROs and/or SDOs are given the flexibility to fully expend the balances from the identified fund sources for purposes stated above.
- d. The ROs shall ensure transparency and accountability in the utilization of the funds and provide regular monthly reports (Annex K) on the activities conducted and the allocation of funds.
- e. Utilization of funds herein shall be in accordance with the existing budgeting, accounting, auditing, and procurement laws, rules, and regulations.
- Each school shall be responsible for the utilization and care of the materials, including their proper circulation between the reading nooks or school library as programmed in the allocation.
- 7. The template for the accomplishment report is included in **Annex K**. ROs shall submit the aforementioned accomplishment reports monthly to the Bureau of Learning Resources (BLR) to effectively monitor the utilization of funds, obligation amount, unobligated amount, disbursement amount, and status of procurement, printing, and delivery, and the progress of project implementation as to the items procured, list of titles selected and used, grade levels covered, and number of new established and improved reading nooks.

- To ensure that all schools offering Kindergarten to Grade 3 (Key Stage 1) have adequate teaching and learning support aligned with DepEd's priorities for foundational skills by 2025, funds shall be reprioritized towards the provision of Structured Pedagogy Lesson Guides for Key Stage 1.
- 2. This initiative will support teachers in facilitating high-quality learning experiences by providing structured pedagogy lesson guides aligned with the curriculum and designed with clear instructional strategies.
- 3. The following activities shall guide the fund utilization:

- 5. The following considerations shall likewise be observed:
  - a. The activities to be funded by the PSF shall be aligned with the goals and objectives of the policy on the provision of structured pedagogy lesson guides for teachers.
  - b. The quantity of the lesson guides shall be determined by the RDs based on the budget breakdown. Moreover, the quantity of the aforementioned materials provided should not fall below the set physical targets.
  - c. The ROs shall ensure transparency and accountability in the utilization of the PSF and provide regular reports on the activities conducted and the allocation of funds.
  - d. Any remaining balance from the allocated amount shall be used for the printing and delivery of additional Structured Pedagogy Lesson Guides including incidental expenses related to the distribution to recipient SDOs/Districts and/or identified delivery drop-off points, as well as other implementation, monitoring, and evaluation activities. Additionally, ROs and/or SDOs are given the flexibility to fully expend the balances from the identified fund sources for purposes stated in this Memorandum.
- 6. Utilization of funds herein shall be in accordance with the existing budgeting, accounting, auditing, and procurement laws, rules, and regulations.
- 7. The template for the accomplishment report is included in **Annex K**. ROs shall submit the aforementioned accomplishment reports monthly to BLD to effectively monitor the utilization of funds, obligation amount, unobligated amount, disbursement amount, and status of procurement, printing, and delivery, and the progress of project implementation as to the items procured, list of lesson guides, and learning areas.
