SELECTED REGIONAL PARTICIPANTS ON THE LINANG E-LEARNING COURSES FOR DEPED NON-TEACHING PERSONNEL

To: Schools Division Superintendents

1. This is in reference to the DepEd Memorandum No. **DM-OUHROD-2025-1520** titled *Registration to the FY 2025 LINANG E-learning Courses: External Learning and Development Interventions (ELDI) for DepEd Non-Teaching Personnel* dated June 13, 2025.

2. The Office of the Undersecretary for Human Resource and Organizational Development (BHROD) has selected participants from the Regional and Schools Division Offices, based qualification criteria, to participate in the **LINANG self-paced e-learning courses through the Udemy platform**. This initiative aims to support the continuous professional development of DepEd non-teaching personnel by providing flexible, accessible, and competency-based learning opportunities.

3. Attached is the **list of authorized participants** who have been granted slots for the said e-learning courses.

4. To facilitate learning, all selected participants are hereby requested to:

- a. Prioritize courses that address their identified technical and/or functional competency gaps and are aligned with their current functional and office mandates;
- b. Allocate a maximum of one (1) working hour per day and/or use non-working hours for course completion to ensure minimal disruptions to official duties. Engagement in the e-learning courses during authorized overtime hours shall be not be allowed; and
- c. Keep their DepEd emails and MS teams active for further information and check-in sessions.

5. An invitation email shall likewise be sent to the registered DepEd email addresses of the selected participants, containing instructions on the activation of their Udemy accounts and access to the courses. The BHROD-Human Resource Development Division shall be responsible in monitoring the learning progress of all selected participants and assisting them on the platform.
