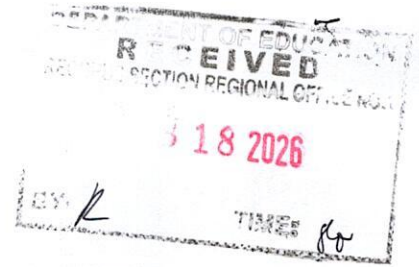

**DATE :** February 16, 2026

In line with the Department of Education's (DepEd) commitment to continuously strengthen and enhance the Philippine Basic Education system, the Learning Systems (LS) Strand, in collaboration with the Operations Strand, shall spearhead a comprehensive review of the Department's existing curriculum and co-curricular programs.

This initiative, to be conducted on **February 20, 2026**, is part of DepEd's broader efforts to ensure that all programs remain responsive, evidence-based, and aligned with the developmental needs of Filipino learners.

A key component of this undertaking is the review of **Values Formation**, with particular attention to the Good Manners and Right Conduct (GMRC) program and related initiatives. This focused review will examine overlapping or complementary programs, such as GMRC/Values Education (VE), the Homeroom Guidance Program (HGP), Anti-Bullying initiatives, and other related efforts. The study aims to identify gaps, overlaps, best practices, and areas requiring policy harmonization, ultimately providing an in-depth analysis to guide policy refinement, program enhancement, and overall system improvement.
