**REQUEST FOR INFORMATION ON LIBRARY COLLABORATION WITH OTHER
 STAKEHOLDERS WITH REFERENCE TO DEPED ORDER NO. 56, 2011 OR THE
 STANDARDS FOR PHILIPPINE LIBRARIES**

To: Schools Division Superintendents

1. Pursuant to DepEd Order No. 56, s. 2011 otherwise known as the *Standards for Philippine Libraries*, particularly Area IC on Linkages and Networking, public school libraries may engage in establishing collaboration to enhance library and information services. I. Purpose

This briefener seeks the approval of the Director of the Bureau of Learning Resources (BLR) for the release of a Memorandum Order requesting librarians in the DepEd Field Offices—Regional Offices (ROs), Schools Division Offices (SDOs), Library Hubs, and Schools—to participate in a data-gathering activity relative to the implementation of **DepEd Order (DO) No. 56, s. 2011, Standards for Philippine Libraries, Standard IX: Linkages and Networking** Please see attached copy of the order).

II. Background and Rationale

DepEd Order No. 56, s. 2011 provides the standards for the operation and management of library hubs and school libraries. Standard IX emphasizes the importance of establishing linkages and networking with stakeholders, institutions, and partner organizations to strengthen library services and learning resource delivery.

At present, there is a need to establish a comprehensive and updated inventory of how Standard IX is being implemented across the DepEd system. Existing data are limited and fragmented, making it challenging to assess current practices, identify gaps, and design responsive capacity-building interventions for librarians.

III. Coverage of the Data Gathering

The proposed Memorandum Order shall request participation from the following:

- Librarians in DepEd Regional Offices
- Librarians in Schools Division Offices
- Library Hub Librarians
- School Librarians (public elementary and secondary schools)

IV. Intended Use of the Data

The data to be gathered shall serve the following purposes:

1. **Inventory and Assessment**
 - Establish a baseline inventory of existing linkages and networking initiatives implemented under Standard IX of DO 56, s. 2011.
 - Identify good practices, gaps, and common challenges encountered by librarians in the field.
2. **Reference for Program Development**
 - Serve as a primary reference for the **finalization of the seminar presentation** on linkages and networking for librarians.
 - Inform the **design and possible conduct of a focused workshop** for seminar participants, ensuring that activities are aligned with actual field needs and contexts.
3. **Policy and Planning Support**

- Provide evidence-based inputs for future policy enhancement, technical assistance, and program planning related to library partnerships and stakeholder engagement.

V. Expected Output

- Consolidated national inventory report on the implementation of Standard IX (Linkages and Networking)
- Refined seminar presentation grounded on field data
- Conceptual basis for a hands-on workshop on developing and sustaining library linkages

VI. Requested Action

In view of the foregoing, approval is respectfully requested for the **release of a Memorandum Order** requesting the concerned librarians in the DepEd Field Offices to participate in the data-gathering activity on the implementation of DO 56, s. 2011, Standard IX.

Approval of this request will support evidence-based planning and strengthen the capacity of librarians to establish meaningful and sustainable partnerships in support of teaching and learning.
