REFINEMENT OF THE REGION I LEARNING RESOURCE INFORMATION SYSTEM (RI LRIS) – PHASE 2

To: Schools Division Superintendents
 All others concerned

1. The Department of Education Region Office I through the Curriculum and Learning Management Division- Learning Resource Management Section (CLMD-LRMS) will conduct the Refinement of the Region I Learning Resource Information System (RI LRIS) – Phase 2 at the National Educators Academy of the Philippines – Region I (NEAP-RI), San Vicente, City of San Fernando, La Union on April 27-30, 2026.
2. The activity aims to:
 - a. reduce average system response and processing time in uploading, searching, retrieval as measured through system logs and user transaction reports;
 - b. increase active LRIS users and improve user satisfaction rating based on system analytics and user feedback surveys;
 - c. ensure that 100% of uploaded learning resources undergo standardized evaluation and validation based on QA reports through the system;
 - d. ensure no erroneous entries as validated through system audits and data quality assessments; and
 - e. develop and deploy at least 5 functional analytics dashboards/reports (e.g. resource gaps, utilization rates) with monthly data updates to support planning and decision-making at SDO and regional levels.
3. The participants in this activity are the following:
 - a. Fourteen (14) Project Development Officers (PDOs); and
 - b. Librarians from San Fernando City and La Union Divisions.
4. Kenneth Zamora Mangaring and Don John N. Ingaran of SDO Dagupan City, and John Paul Pantaleon of SDO Pangasinan I are also requested to attend considering their expertise in system refinement.
5. The participants are expected to bring their laptop, extension cord and back-up pocket Wi-Fi to facilitate the production of the desired outputs.
6. The first meal to be served is PM snack on April 27, 2026 and the last meal will be lunch on April 30, 2026. All participants are expected to be at the venue before 3:00 P.M. on April 27, 2026. The opening program will start at 3:30 P.M. Moreover, the participants are required to register at <https://tinyurl.com/Pre-RegREFINELRISP2> on or before April 15, 2026 until 5:00 PM.
