REITERATION ON THE STRICT IMPLEMENTATION OF MONITORING AND REPORTING OF THE SENIOR HIGH SCHOOL VOUCHER PROGRAM (SHS-VP) IN REGION I

1. In line with the Department's commitment to ensure transparency, accountability, and effective implementation of the Senior High School Voucher Program (SHS-VP) for all participating private schools in Region I, School Year 2025–2026, this Office reiterates the strict compliance with the prescribed monitoring and reporting mechanisms across all Schools Division Offices (SDOs) as reflected in Regional Memorandum No. 474, s. 2025 and DepEd Order No. 020, s. 2023, titled "Guidelines on the Implementation of the Senior High School Voucher Program".

2. This activity aims to strengthen all SHS-VP Task Forces and ensure that monitoring activities are conducted regularly and systematically, covering all participating schools within their jurisdiction.

3. In this regard, all SDOs are directed to observe the following timelines:

a. **May 8, 2026:** Submission of the approved composition of the SDO SHS-VP Task Force duly signed by the Schools Division Superintendent through email at qad.rol@deped.gov.ph.

b. **May 11-29, 2026:** Conduct of comprehensive monitoring activities to assess program implementation, compliance of participating schools, and utilization of voucher grants.

c. **June 10, 2026:** Submission of accurate and complete monitoring results highlighting findings, issues encountered, and corresponding recommendations and results. Please ensure that all reports are validated, properly documented, and supported by necessary evidence duly signed by the Schools Division Superintendent.
