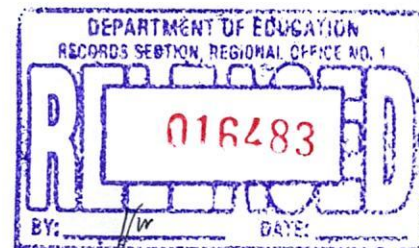

SUBMISSION OF LIST OF TOP FIVE SENIOR HIGH SCHOOL GRADUATES FOR THE BAGONG PILIPINAS MERIT SCHOLARSHIP PROGRAM

To: Schools Division Superintendents

1. In connection with the implementation of the Bagong Pilipinas Merit Scholarship Program (BPMSP), all public and private Senior High Schools (SHSs) are hereby requested to submit the official list of their top five (5) Senior High School graduates for School Year 2025–2026.
2. The BPMSP supports qualified students pursuing highly competitive priority degree programs and Technical-Vocational Education and Training (TVET) diploma programs identified by CHED and TESDA. The program aims to provide opportunities for deserving learners, address hard-to-fill occupations, bridge local workforce gaps, and contribute to national development.
3. All public and private SHSs shall encode the required information through this link: tinyurl.com/R1BPMSP.
4. In addition to the top five (5) SHS graduates, schools may also include in the same link other learners who obtained a general average of 95 or higher, even if they are not included in the top five (5), for possible consideration and reference.
5. The required data shall be submitted on or before May 13, 2026 to ensure timely consolidation and submission to CHED Regional Office I.
