**EXTENDED PRE-REGISTRATION DEADLINE FOR FY 2026 EXTERNAL
 LEARNING AND DEVELOPMENT INTERVENTIONS FOR DEPED
 NON-TEACHING PERSONNEL**

To: Schools Division Superintendents

1. This is in reference to the DepEd Memorandum No. **DM-OUHRODI-2026-1122** titled *Registration to the FY 2026 LINANG E-learning Courses: External Learning and Development Interventions (ELDI) for DepEd Non-Teaching Personnel* dated April 7, 2026.
2. The E-learning (ELDI) Courses are intended for the First and Second-Level Field Non-Teaching Personnel holding permanent, contractual, and co-terminus employment status. In addition, the ELDI Courses are designed to strengthen the core, functional, and leadership competencies to support DepEd's mandates under the FY 2026 Learning Interventions for Navigating Advancements and Nurturing Growth (LINANG) Program.

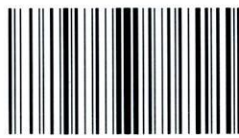
