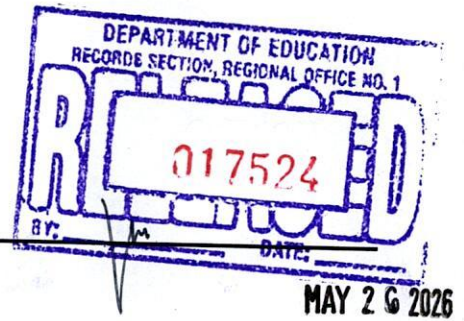

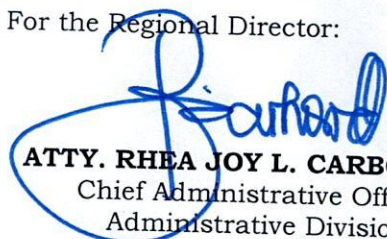

**APPROVAL OF THE CREATION OF 32,916 NEW TEACHING ITEMS FROM
 KINDERGARTEN TO GRADE 12 AND ALTERNATIVE LEARNING SYSTEM FOR THE
 SCHOOL YEAR 2026-2027**

To: Schools Division Superintendents

1. Enclosed is a copy of Memorandum DM-OUHRODI-2026-1786, dated May 14, 2026, from Wilfredo E. Cabral, Undersecretary for Human Resource and Organizational Development and Infrastructure, re: Approval of the creation of 32,916 New Teaching Items from Kindergarten to Grade 12 and Alternative Learning System for the School Year 2026-2027. The content has been duly noted for information, guidance, and appropriate action.
2. The Schools Division Offices (SDOs) are directed to refer to DM-OUHRODI-2026-1215 titled Advanced Information on the Creation and Deployment of New Teaching Items for School Year 2026-2027 dated April 21, 2026, to effectively facilitate the filling up of the new teaching items.
3. Moreover, to facilitate monitoring of the issuance and receipt of NOSCAs from DBM to the field offices and Ius, the mobile application "InsightEd" shall be utilized by all Human Resource Management Officers (HRMOs). The BHROD-SED shall conduct an online orientation via MS Teams to introduce the application and assist the HRMOs in navigating and utilizing the platform. Details of the orientation shall be issued through a separate Memorandum.
4. In addition, the accomplishments of the Schools Division Offices in terms of the filling up of the new teaching items shall be monitored through the Program Management Information System (PMIS). Encoding of reports in the system shall commence on June 08, 2026.
5. Lastly, pursuant to DBM's National Budget Circular No. 549 dated October 21, 2013, all field offices are also reminded to ensure monthly updating of the Personal Services Itemization and Plantilla of Personnel (PSIPOP).
6. Immediate dissemination of and compliance with this Memorandum are desired.

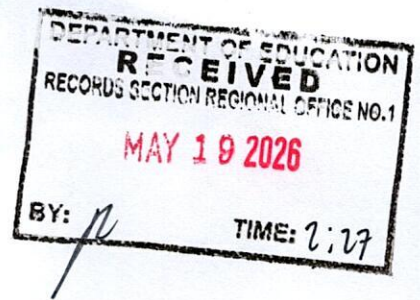

This is to inform all concerned field offices that the Department of Budget and Management (DBM) has approved the creation of **THIRTY-TWO THOUSAND NINE HUNDRED SIXTEEN (32,916)** new teaching items for Kindergarten to Grade 12 and Alternative Learning System (ALS) for SY 2026-2027 through a letter dated 07 May 2026.

In this connection, the DBM Regional Offices (DBM-ROs) shall issue the Notice of Organization, Staffing, and Compensation Action (NOSCA) directly to **Schools Division Offices (SDOs)** for **Kindergarten/Elementary** and **Senior High School (SHS)** positions **including ALS**, and to **Implementing Units (IUs) for Junior High School (JHS)** based on the deployment list prepared by DepEd. For the deployment list, kindly refer to the attachment in the *DM-OUHRODI-2026-1215* or *Advance Information on the Creation and Deployment of New Teaching Items for School Year (SY) 2026-2027* dated 21 April 2026.

To effectively facilitate the filling-up of these new teaching items and to ensure that the lump sum appropriated for this purpose shall be fully utilized within the

indicated fiscal year, the Bureau of Human Resource and Organizational Development (BHROD) would like to reiterate the following key processes articulated in the above-cited DM:

1. Prioritize deployment of items based on the most recent teacher needs analysis for Kindergarten/Elementary and SHS;
2. Expedite the recruitment and selection process; and
3. Coordinate with the beneficiaries under special hiring arrangements, specifically, those covered by the Department of Science and Technology (DOST) through Republic Act (RA) No. 10612 and RA No. 7687, collectively known as the Science and Technology Scholarship Acts, as well as those under the Department of Migrant Workers' "Sa Pinas, Ikaw ang Ma'am/Sir" (SPIMS) Program to inform them of the schedule of demonstration teaching, interview, and the documentary requirements needed to be submitted.

Similarly, it is expected that all SDOs have already prepared their respective Registry of Qualified Applicants (RQAs) to achieve a 100% filling-up rate by the end of September 2026.

Moreover, to facilitate monitoring of the issuance and receipt of NOSCAs from DBM to the field offices and IUs, the mobile application "**InsightEd**" shall be utilized by all HRMOs. Through the said application, HRMOs shall upload copies of the NOSCAs received and indicate the corresponding number of teaching items by position and by level of education covered by the issued NOSCAs for monitoring and validation purposes.

In this regard, the BHROD-School Effectiveness Division (BHROD-SED) shall **conduct an online orientation via MS Teams** to introduce the application and assist the HRMOs in navigating and utilizing the platform. The details of the orientation shall be issued through a separate Memorandum.

Further, the accomplishment of the ROs/SDOs in terms of filling-up of these new teaching items shall be monitored through the **Program Management Information System (PMIS)**. Encoding of the report to the system by the SDO Administrative Officer shall begin on **08 June 2026**.

Lastly, pursuant to DBM's National Budget Circular No. 549 dated 21 October 2013, all field offices are also reminded to ensure **monthly updating of the Personal Services Itemization and Plantilla of Personnel (PSIPOP)**.
