**REVISED ASSIGNMENT OF QUALITY ASSURANCE DIVISION (QAD)
 PERSONNEL AND THEIR RESPECTIVE SCHOOLS DIVISION
 OFFICE (SDO) JURISDICTIONS**

1. Relative to Regional Memorandum No. 04, s. 2026, titled "Updated Assignment of QAD Personnel and their Respective SDO Jurisdictions," this Office hereby issues a revised assignment of personnel and corresponding Schools Division Office (SDO) jurisdictions under the Quality Assurance Division (QAD).
2. This revision is necessitated by the following personnel movements:
 - a. The transfer of **Dr. Melisa G. Del Prado** to the Schools Division Office of San Carlos City in her new capacity as Public Schools District Supervisor (PSDS) effective July 16, 2026; and
