To: Schools Division Superintendents

1. In reference to Regional Memorandum No. 1199, s. 2026, entitled "*Conduct of the Regional Training on the Administration of the PISA-Based Test for Schools (PBTS) Philippines 2026*," this Office announces the venue of the said activity at Ynad's Place Hotel & Resort, Barangay Namtutan, City of San Fernando, La Union on September 21-22, 2026.
2. All participants are required to bring their own laptop and extension cord for use during the practical exercises and workshop sessions.
3. The meals for the participants shall be provided beginning with the PM snacks on September 21, 2026, and ending with lunch on September 22, 2026.
4. Travel expenses and other incidental expenses relative to participation in this activity shall be charged against the OSEC-1-26-04426. If the downloaded funds is insufficient, expenses shall be charged to MOOE/Local Funds or other source of funds subject to existing budgeting, accounting, auditing, and procurement laws, rules, and regulations.
5. Participants whose permanent station is outside a reasonable commuting distance may be provided accommodation in the designated hotel to minimize repeated transportation expenses, travel time, and productivity losses associated with daily commuting, while ensuring their safety and timely participation in the required activities.
6. Confirmed participants who fail to stay in the assigned accommodation without providing prior notice and a written justification shall be required to refund the full accommodation cost incurred for them. The refund shall be made in accordance with applicable government accounting and auditing rules and regulations.
7. Any participant who is unable to attend or needs to make changes to the confirmed accommodation arrangement shall provide prior notice to the Regional Office and a written justification. The concerned SDO shall ensure that appropriate notification is made within the prescribed period.
8. All identified participants are required to pre-register through the online registration link provided by the Regional Office on or before September 19, 2026:
